As an associate in the product liability and mass torts group, Shelby was an integral member of trial teams defending international pharmaceutical companies, obtained summary judgment on behalf of academic medical center in medical malpractice action, and counseled global companies about litigation holds, e-discovery issues, and the potential ramifications of spoliation.
