Obtained a decision from the Pennsylvania Supreme Court affirming the unanimous decision from the Commonwealth Court of Pennsylvania, affirming decisions of the Court of Common Pleas and the Cheltenham Township Zoning Hearing Board in favor of our real estate developer client, in a case of first impression. The matter centered on a dispute over whether the filing of a mandatory sketch plan creates a vested right for consideration of the plan, as well as any future zoning applications related thereto, under the zoning ordinance in effect when the sketch plan was filed. We convinced the courts that the initial filing does create such a right, and that the township's challenge to the authority of the zoning hearing board to render the initial favorable decision for our client was without merit. The Commonwealth Court's decision, which was affirmed by the Supreme Court of Pennsylvania, permits the client to move forward with a land development plan for the contemplated five-building apartment project, featuring 216 units and a community building.
